
















North Carolina is Changing

- The state's total population has exceeded 10 million!
- North Carolina ranks 9th nationally, both in total population and in the number of people 65 and older.
- By 2028, one in five North Carolinians will be 65 and older. By 2031, there will be more people 65 and older than children 0-17.
- The state has more people 60 and older than under 18 years.
- In 2019, 82 counties in the state had more people 60 and older than under 18 years. By 2025, this number is expected to increase to 89 counties and by 2038 to 95 counties.
- In 2019, an estimated 44,306 people 60 and older migrated from other states and abroad to North Carolina.
- In the next two decades, our 65 and older population will increase from 1.7 to 2.7 million, a projected growth of 56%.
- The projected growth among the age groups 65-74 (29%), 75-84 (87%) and 85+ (116%) indicates that as the baby boomers continue to age, there will be an increased proportion of older adults in the state creating challenges for long-term services and supports

- 6-8 years but up to 20 years






Caregivers in NC






Approximately One In Three US Adults Completes Any Type Of Advance Directive For End-Of-Life Care

What is an Advance Directive?



An advance directive is a legal way to tell your loved ones and doctor the types of care you want if you are unable to make medical decisions for yourself.



Advance Directive Elements





Living Will

A living will tells medical professionals and your family which medical treatments you want to receive or refuse, and under what conditions.






Share Your Wishes: Decide, Create, Share



Discuss your wishes with your loved ones.

- Let family members know in writing who is your health care agent and why.
 - Review documents with everyone concerned.





Medical Orders for Scope of Treatment (MOST) Form

- A MOST form is a doctor's order that helps you keep control over medical care at the end of life.
- A MOST form may be used in addition to -- or, sometimes, instead of -- a DNR order.
- You need to consider a MOST only if you're facing a life-threatening medical condition. If you're healthy, you need only a living will and health care power of attorney to provide a full set of wishes for your treatment in the event of an unexpected accident or medical crisis.
