Valerie Hillings became director of the North Carolina Museum of Art (NCMA) in November 2018. Prior to joining the NCMA, she received her B.A. in art history from Duke University and her M.A. and Ph.D. in art history from the Institute of Fine Arts, New York University. Since 2004 she has held senior positions for the Solomon R. Guggenheim Museum and Foundation and worked on projects for museums in its global constellation—Guggenheim Museum Bilbao; Deutsche Guggenheim, Berlin; Guggenheim Hermitage Museum, Las Vegas; and the Peggy Guggenheim Collection, Venice—and with partner institutions in Australia, Europe, and the Middle East.

During her tenure at the Guggenheim, Hillings rose through the curatorial ranks and curated more than 15 exhibitions on four continents, among them RUSSIA! (2005–6); Hanne Darboven: Hommage à Picasso (2006); Guggenheim Collection: 1940s to Now (2007); Picturing America: Photorealism in the 1970s (2009); ZERO: Countdown to Tomorrow, 1950s–60s (2014); and The Creative Act: Performance, Process, Presence (2017). ZERO, inspired by Hillings's doctoral thesis, was a 2014 AICA nominee for Best Thematic Show in New York, and the exhibition's website won a Webby Award. She collaborated with artists including Marina Abramović, El Anatsui, Angela Bulloch, Hanne Darboven, Susan Hefuna, Tomás Saraceno, and Günther Uecker on commissions, exhibitions, and public programs.

Hillings provided curatorial leadership for the Patrons Circle, a high-level Guggenheim membership group, and the Middle Eastern Circle affinity group, which supports acquisitions and programming at the Guggenheim Museum on an annual basis. She also served on the New York museum's photography acquisition committee. In 2009 she joined the Guggenheim's dedicated Abu Dhabi Project staff, tasked with planning for the Guggenheim Abu Dhabi, a museum of modern and contemporary art currently under development in the United Arab Emirates in the Saadiyat Cultural District in Abu Dhabi. As curator and associate director of curatorial affairs, Hillings led a team that brought together leading experts in a variety of art historical fields to develop a strategy for originating for the Guggenheim Abu Dhabi acollection of art since the 1960s made around the world in all mediums. She directed a robust acquisitions program, preopening exhibitions, public programs, and publications, realized in partnership with the Department of Culture and Tourism–Abu Dhabi and aimed at developing local audiences and increasing awareness of the future museum.

In addition to her Guggenheim projects, Hillings has published and publicly lectured on curatorial practice and on various topics in post–World War II art history and contemporary art. She served on the jury for the Kandinsky Prize for Russian contemporary art from 2007 to 2009 and the international ZERO Foundation Scientific Board, Düsseldorf, Germany, from 2011 to 2014. From 2014 to 2017, she was a member of the Board of Advisors for the Nasher Museum of Art at Duke University. In 2016 she was a fellow at the Center for Curatorial Leadership in New York.

Mina Lea Levin is a native of Philadelphia who moved to central North Carolina in 1975 after completing her education at Bryn Mawr College and the University of Pennsylvania School of Medicine. After her medical residency at UNC Hospital, she practiced Internal Medicine for 26 years. During that time, in addition to private practice, she was a UNC Clinical Associate Professor of Medicine in Raleigh at the Wake AHEC and worked for 6 years as the Medical Director of Hospice of Wake County.

Since retiring she has been a docent at the North Carolina Museum of Art for sixteen years and is currently a member of the NC Art Museum Foundation Board of Directors. In the past, she has served on the NCMA Docent Board, the Advisory Board of the Raleigh Contemporary Art Museum (CAM Raleigh) for 6 years, including three as its chairperson, and the Board of Hospice of Wake County for six years where she acted as Secretary and also Chair of Strategic Planning. She was also active in Raleigh Fine Arts and served in 2010 as its Vice President for programs.

Along with her husband, Ron Schwarz, Mina enjoys traveling in the US and Europe, attending local theater, and participating in play seminars in major cities. They have a collection of contemporary art glass and Japanese contemporary ceramics. She is an avid knitter and reader of historical fiction.

Lyle Humphrey is Associate Curator of European Art and Collections History at the North Carolina Museum of Art. Her research and publications explore a range of topics in north Italian painting and manuscript illumination and the collecting of ancient, medieval, and early modern art in America. Since joining the NCMA in 2013, Lyle has curated a focus exhibition on a rediscovered bronze medallion designed by Gianlorenzo Bernini (2014); a loan exhibition of Venetian paintings and incunabula, "Glory of Venice: Renaissance Paintings 1470–1520" (co-curated with David Steel, 2017); and, most recently, a series of exhibitions dedicated to the history and development of the NCMA, a subject on which she has also published several articles. In 2015, her book on the manuscript patronage of Venetian confraternities and guilds was published by the Fondazione Giorgio Cini in Venice with the support of the Regione del Veneto and the Gladys Krieble Delmas Foundation. Lyle earned her M.A. and Ph.D. from New York University's Institute of Fine Arts.

Kara Millonzi is the Robert W. Bradshaw Distinguished Professor of Public Law and Government at the UNC-Chapel Hill School of Government. She specializes in local government finance law, general county law, school finance, utilities finance, capital finance, and incorporation. She administers the Coates' Canons Local Government Law Blog and has authored well over 100 posts on issues related to local government law and finance. She also has authored numerous publications, including *A Guide to Billing and Collecting Public Enterprise Utility Fees for Water, Wastewater, and Solid Waste Services, Introduction to Local Government Finance* (now in its 4th edition), and *The Governance and Funding Structure of North Carolina Public Schools.* She teaches several core finance and local government courses.

Kara is the faculty lead for Lead for North Carolina, a fellowship program that aims to recruit, train, and place the state's most promising young leaders in paid local government fellowships as a means of strengthening our public institutions, supporting our local communities, and cultivating a new generation of public service leaders. Before joining the School, Millonzi practiced law with Testa, Hurwitz & Thibeault, LLP in Boston and clerked for a federal judge. She is a member of the North Carolina State Bar and the Bar of the Commonwealth of Massachusetts. Millonzi earned a BA in economics, summa cum laude, Phi Beta Kappa, from the University at Buffalo and an MA in economics from the University of Maryland at College Park. She earned a JD, with highest honors, Order of the Coif,

from the University of North Carolina at Chapel Hill, where she served as editor in chief of the North Carolina Law Review.

Chief Justice Cheri Beasley appointed McKinley Wooten Jr. as director of the North Carolina Administrative Office of the Courts (NCAOC) on March 2, 2020. Wooten had been serving as interim director since February 28, 2019, managing the administrative services provided to the Judicial Branch's more than 6,400 employees and 213 judicial facilities in every county of the state. He is the first African American to serve as director of the NCAOC. He previously served as deputy director of NCAOC, deputy secretary of the North Carolina Department of Administration, and inspector general at the North Carolina Department of Justice.

His leadership role and responsibilities ultimately help North Carolina's unified court system operate more efficiently and effectively, taking into account each courthouse's diverse needs, caseloads, and available resources. Wooten has a special interest in supporting, recognizing, and celebrating the individual skills and talents of each Judicial Branch employee. He also is very focused on three I's for the court system: innovation, inclusion, and integrity.

Prior to his appointment as interim director, Wooten was a deputy director with NCAOC responsible for overseeing statewide services for courts, including language access, recovery treatment courts, a help desk for clerks of court, child custody and permanency mediation, the Guardian ad Litem program, and the Court Improvement Program. Additionally, he held an integral leadership role in the Judicial Branch's statewide eCourts initiative, a multi-year effort to modernize court technology and case management systems. He also serves on a number of government boards and committees, including the Chief Justice's Equal Access to Justice Commission, Wake County Human Services Board, UNC School of Government Foundation Board, and North Carolina State Employees' Credit Union, serving as chairperson from 2011-13. Wooten volunteers with Big Brothers Big Sisters of the Triangle and serves as minister of music at his local church.

A native of Kinston, NC, Wooten is a Phi Beta Kappa graduate of Morehouse College with a bachelor's degree in English, and he received a J.D. from Vanderbilt University Law School. He is married to Laura H. Wooten, and they are the proud parents of a young adult son and daughter.

Kevin Leonard is the Executive Director of the North Carolina Association of County Commissioners (NCACC), which represents all 100 North Carolina Counties. Kevin has worked with the NCACC since 2009 serving in multiple roles including: Legislative Coordinator, Director of Government Relations, and Deputy Director. Previously, Kevin was Senior Government Relations Manager at Womble Carlyle Sandridge & Rice; Director of Government Affairs for the North Carolina Department of Labor; Chief of Staff for a member of the North Carolina General Assembly; Legislative Assistant for a Member of the United States House of Representatives; and Production Assistant with C-SPAN.

Judge Regina R. Parker graduated from Williamston High School in 1985 and thereafter received the Bachelor of Science degree in Criminal Justice from East Carolina University in 1989. Following undergraduate school, Judge Parker earned the Juris Doctor degree from the North Carolina Central University School of Law. Following law school, Judge Parker clerked on the North Carolina Court of Appeals for the Honorable Clifton Johnson. In 1993, she became a partner with the law firm of Smallwood, Rodgers and Hayes where she worked as a trial attorney until 1997. Judge Parker joined the law firm of the esteemed, late Attorney Earl T. Brown where she worked from 1998 until 2001, practicing juvenile and real estate law.

In 2001, Governor James B. Hunt appointed Judge Parker to the District Court bench in the Second Judicial District, comprising Beaufort, Hyde, Martin, Tyrrell and Washington County. This historic appointment made Judge Parker the first woman and African American judge in the Second Judicial District. Early in her tenure on the District Court, Judge Parker initiated the Teen Court program in the Second Judicial District, diverting teen offenders to a specialty, educational but non-judicial proceeding. During her time on the bench, Judge Parker has been pleased to serve on the Juvenile Crime Prevention Committee for Martin, Beaufort, and Washington County and by appointment to the North Carolina Courts Commission. Serving for more than 19 years, Judge Parker has been re-elected to the District Court by the citizens of the Second Judicial District without opposition.

On March 1, 2018, Chief Justice Mark Martin of the North Carolina Supreme Court appointed Judge Parker to the position of Chief District Court Judge for the Second Judicial District. As the first female and African-American Chief District Court Judge in this judicial District, Judge Parker has begun to tackle head-on the mental health and opioid epidemics, which impact the lives of thousands of families in eastern North Carolina. As the founding member of the Opioid Crisis and Mental Health Coalitions, she has convened a multi-disciplinary alliance of professionals to address

these crises. Currently, she is developing a Drug Court and Truancy Court to provide drug-addicted offenders with the intensive, individualized treatment they need to become healthy, law-abiding, and productive family and community members. With the School to Justice Partnership North Carolina, Judge Parker has taken the lead to assemble community stakeholders in the Second Judicial District to develop and implement strategies to keep youth in school and out of court in Beaufort, Hyde, Martin, Tyrrell and Washington County.

Judge Parker serves on numerous community and professional boards. Her passion, however, continues to be serving the Lord, Jesus Christ, and her community. She is a member of Believer's Fellowship Conference Center where Rick Carson is the pastor. Judge Regina Parker is married to Dr. Norris Parker, and they have two daughters, Maya, 21, and Morgan, 15.
